INFORMATION ON TRAINING SCHOLARSHIPS

The HKSEMR is now able to award up to HK\$100,000 per annum in Training Scholarships for members of the Society who are unable to obtain any or sufficient funding from other sources. The Fellowship should serve to encourage awardees to engage in additional education/research-related activities during the overseas training period. Preference will be given to younger members of the Society who are proposing to obtain training overseas in techniques or areas of special relevance to research or clinical practice being undertaken in Hong Kong. It is a condition of the Scholarship that the trainee will return to work in Hong Kong at its conclusion. Where the applicant has obtained partial but insufficient funding from other sources, the Committee is prepared to consider partial (top-up) funding. Each Training Scholarship is worth a maximum of HK\$30,000.

- Notes:
- (1) The applicant must be a paid-up member of the HKSEMR and have been a paid-up member of the Society for more than one year.
 - (2) Applications should be submitted by 31st March, and will be considered in April of each year.
 - (3) The maximum amount awarded to any one applicant is HK\$30,000, and a scholarship will not be awarded to the same applicant in two consecutive years.
 - (4) Applications will be reviewed by the Council of the Society. The decision of the Council will be considered final. The Council may require the applicant to attend for interview.
 - (5) After the conclusion of the Training Scholarship a brief report should be submitted to the Council not later than three months after return, together with a balance sheet indicating how the money was spent, and relevant receipts.
 - (6) The HKSEMR should be acknowledged as having provided financial support, in any subsequent publication that results.
